1. Application from the Lincoln County Rodeo Association Inc. for three temporary Class "B" (picnic) licenses to sell fermented malt beverages at the Merrill Festival Grounds during the Wisconsin River Pro Rodeo, June 12-14, 2020.

A copy of the license application was in the meeting packet.

It was noted that the 2020 rodeo has been cancelled, so there is no need to consider the license application.

City Clerk Heideman has authorized a refund of \$30 to the Lincoln County Rodeo Association Inc.

Alderman Russell reported that the Lincoln County Fair Board will be meeting soon to discuss the status of the 2020 fair.

IV. Other agenda items to consider:

1. COVID-19 Updates:

Lincoln County Health Director Shelley Hersil

Lincoln County Health Department Director Hersil gave a verbal update.

To date, approximately 200 people in the county have been tested. All have been negative to date, but some are still pending. The amount of testing has increased recently.

The “reopening” of the county will be a gradual process.

Lincoln County Emergency Planning Manager September Murphy

Lincoln County Emergency Management Director Murphy reported that various agencies have been cooperating with each other and meeting weekly to discuss and address COVID-19 concerns.

Lincoln County Health Department Director Hersil and Lincoln County Emergency Management Director Murphy then answered questions related to the COVID-19 pandemic. Until further notice, they will both be invited to attend Health and Safety Committee meetings to provide COVID-19 update reports.

2. Consider reducing alcohol beverages licensing fees in response to COVID-19 pandemic.

Information was in the meeting packet.

Alderman Russell remarked that the bars, particularly those that are not continuing to serve food, have been adversely affected the most by the COVID-19 pandemic.

Bob Kort added that the bars lost their revenue source, but they still have bills to pay. Mike Caylor surmised that the “lockdown” of bars could last six months, and suggested that the fee could be decreased by half.

It was noted that there is no minimum fee for a Class “B” license and the minimum fee for a “Class B” license is \$50.

Any fee adjustment would need to be considered in the form of an ordinance by the Common Council.

Motion (Blake/Russell) to decrease for the 2020-2021 license year only, the fee for a Class “B” license from \$100 to zero and the fee for a “Class B” license from \$500 to \$50.

Every year has its challenges and opportunities, so 2019 was no different. We had our share of personnel changes. Battalion Chief Steve Hintze retired, so we had a promotion process and hiring process. Unfortunately in 2019, we also lost a couple of our retirees (Steve Peterson and Fritz Heller). Both of these men had a profound impact on our department. 2019 also brought a host of new events and programs as we continue our positive forward progression as an organization. These changes are designed to improve the effectiveness and efficiency of our operations. We strive to fulfill our mission every day. Our call volume and department activities continue to increase while we operate with fewer staff than we did in when I started in 2002. We cannot be afraid to change and try different strategies to deal with the changes that we have seen in the fire service and will continue to see in future years.

Here is the chronological breakdown of significant administrative and fire department events that occurred in 2019:



January 29 – 2% Dues Audit conducted by Department of Safety & Professional Services (DSPS). We were in substantial compliance with SPS 314 and State Statute 101.575(6).



March 2 – Donated used and/or expired firefighting equipment to LaPointe (WI) Fire Department after they sustained a significant fire at their fire station.



March 5 – Started advertising for new Firefighter/Paramedic hiring process. Advertising included local, regional, state, and national platforms to try and recruit candidates. Unfortunately we only received 3 applications.



March 21 – Conducted a special presentation to the Lincoln County EMS Committee to consider adding additional staffing to MFD as EMS calls have continued to increase. No action was taken by the committee.



April – New Computer Aided Dispatch (CAD) software, Zuercher, is implemented for us. This software integrates with our primary database, ImageTrend. There was some additional cost for getting this. The software works in all of our apparatus.



April 29 – Attended and participated in the funeral of retired Firefighter/EMT Steve Peterson. He is greatly missed, but his legacy will live on. Even into his retirement, Steve had a big impact on our community.



May 16 – Firefighter/EMT Eric Trempe's first day on the job at MFD. He was hired as an EMT originally, but was in the process of his final testing for paramedic. Eric becomes the 188th member of the department. He previously served with the South Area Fire & Emergency District and the Village of Maine Fire Department. Eric also serves our country in the US Army Reserves.



May 28 – Battalion Chief Steve Hintze's last day on shift. He served the Merrill community for 27 years. Steve was largely responsible for revamping the department's fire prevention program. When he retired, he was in charge of the Public Relations/Education and Station Maintenance. During his career, he was very active with FD and community events like MFC Charity Softball Tournament, Bigs with Badges, Silver M, St. John Lutheran Church, and coaching various youth sports. His service to the community was second to none.

June 1 – Battalion Chief Steve Hintze's official retirement date.



June 2 – Firefighter/Paramedic Jon Leiskau promoted to Battalion Chief – Operations to replace Hintze. Jon has served the department for the past 18 years. He was the top candidate from the pool of 5 who participated in the intensive promotional process which included a written test, peer review, two separate interviews, writing assignment, and assessment center. BC Leiskau also participates in many of the departments' off-duty volunteer events as well.



June 11 – We hosted the first ever, all city employee safety day. This was designed after the annual Firefighter Stand-down event that MFD participates in along with fire departments across the country. The presentation featured back injury prevention, work compensation review, sexual harassment, health insurance & EAP overview, and fire extinguisher training. The presentation was recorded as well.



June 17 – Badge pinning ceremony was held for Firefighter/Paramedic Eric Trempe and Battalion Chief Jon Leiskau. The department is very fortunate to have them serving the Merrill community.



June 19 – New, non-emergency service of filling swimming pools was added to the department. This service is performed by on-duty crew. There is a nominal charge for the service. This is just another between alarm valuable service provided by the department. The department had 12 applications for pool fill services in its inaugural year.



July 20 – MFD lead a MABAS Interdivisional Division 155 Task Force response to Langlade County to support search & Rescue efforts after major storm the day before. This was the first ever response of this type from Lincoln County.



August 1 – Pastor David Szeto becomes the fire department's first fire chaplain. He was selected after a selection process conducted by members of the department. His role will be to support the mental, psychological, and spiritual welfare of department members and their families. This is an unpaid position.



August 27 – Members participated in weekly clean up and maintenance of the State Firefighter Memorial Park in Wisconsin Rapids. This was the first time our department participated in cleanup of the memorial. This action was a small tribute to the department's only line of duty death, Lieutenant Thomas Beckman in 1978. Beckman is memorialized on the shrine at the park.

August 28 – Started negotiations with Merrill Firefighters Local 847 on a new Collective Bargaining Agreement (CBA) which expires that the end of the year. Unfortunately a contract could not be settled and both parties proceeded to mediation/arbitration through the state. City management also met with representatives from the Towns of Merrill, Scott, and Rock Falls to discuss the rural fire contract which ended at the end of the year. According to articles of the existing contract, the contract was extended on a year-to-year basis since a new contract was not agreed upon.



September 1 – Approved new fire department patches. The decision to use the new patches was voted on by the members.



October 11 – Attended and participated in the funeral service of retired Deputy Chief Frederick “Fritz” Heller. He was the oldest living retired member of our department and routinely attended the monthly retiree breakfast. Fritz was great to have around the fire station, as the crews enjoyed listening to his stories of fires from the past.



October 30 – Start of sharing a reserve ambulance with Tomahawk EMS. Instead of trading in the oldest ambulance from Tomahawk when they received their new one, the county EMS committee authorized keeping the ambulance so both services could maintain their respective fleet during periods when front line apparatus is out of service.

Those were just a snapshot of issues and events that occurred during the year. Throughout 2019, our department continued to handle the challenges and opportunities that we faced each and every day. Unfortunately, there will be no shortage of new challenges in the future. One of those challenges will be the ongoing issue of recruitment and retention. While we are optimistic to get more candidates in the future, it was frustrating to only have 3 in our last process. We must be open for consideration of hiring the right Firefighter/EMT and sending them on to Paramedic class. This will be an additional cost for our department and change to our operations. The same challenges would apply to command staff positions as well. There must be a continuation of benefits for management positions as well.

Funding at the local city and county levels will continue to have an impact on the services that we can provide. The current collective funding of the department through the county ambulance contract and rural fire contracts has allowed our community to get the best value in emergency services. As always how that formula is figured is an issue especially in a year when the contracts are negotiated. Nobody wants to pay more than they need to, but the reality is that by everyone contributing we are able to provide the Merrill community the high quality service it has come to know for the past 130 years.

As our cover statement summarizes, we must learn from our past so we can best plan for our future.

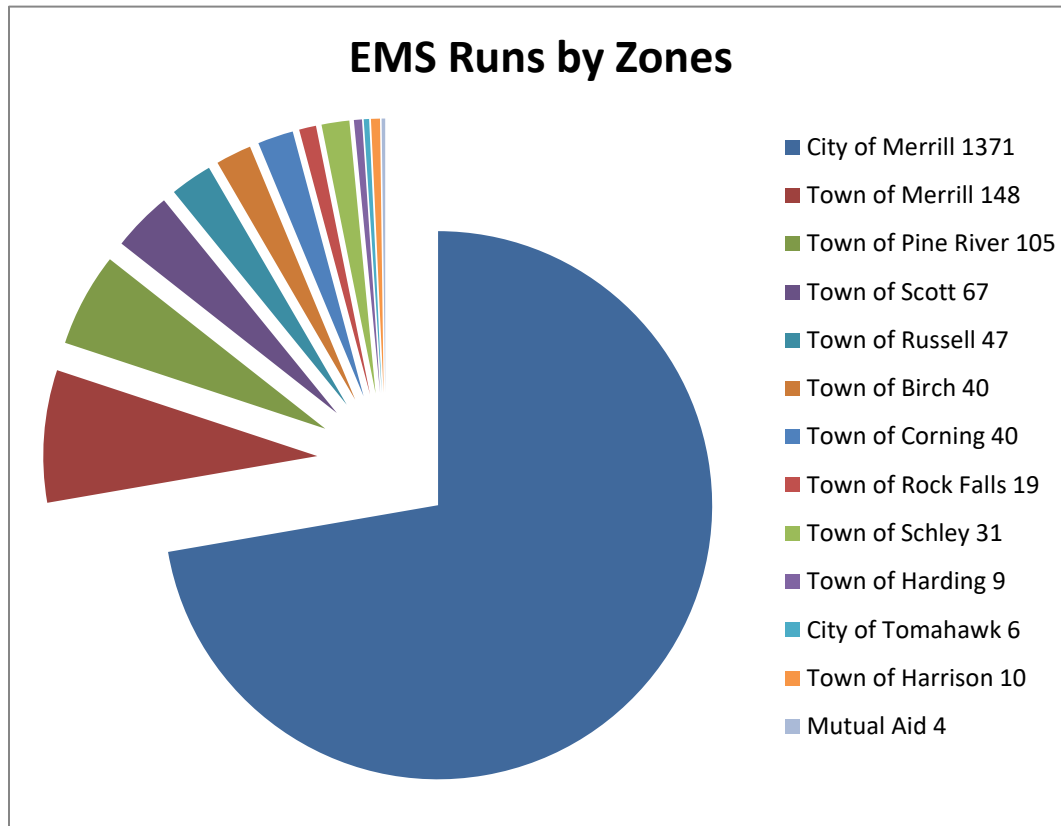

EMS Division

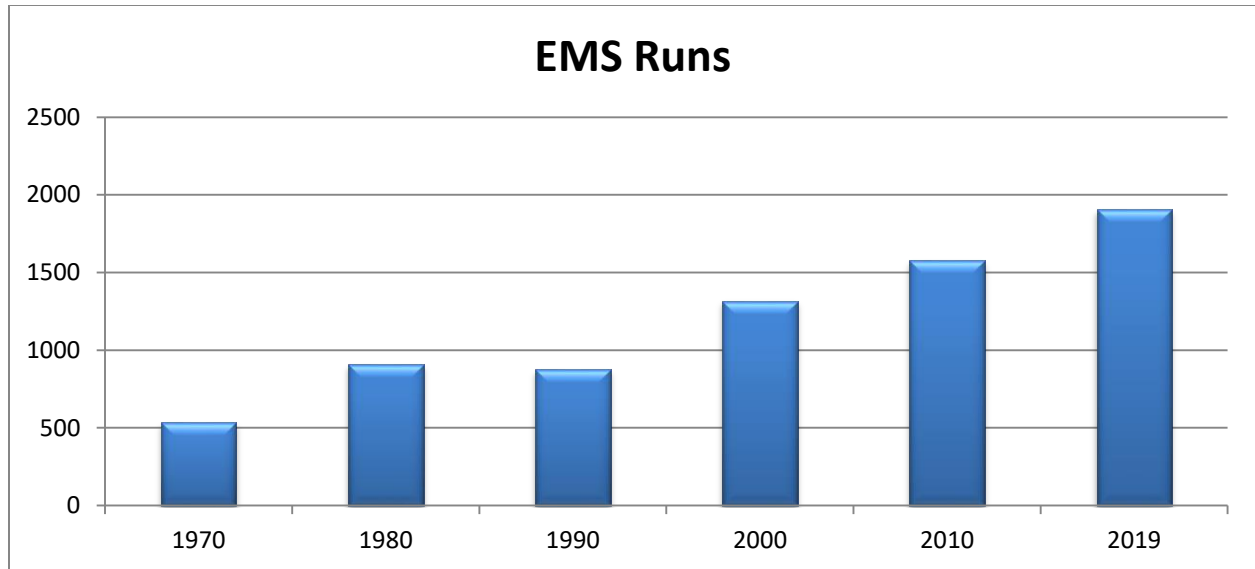
2019

This is the 2019 annual EMS report for the Merrill Fire Department. The Merrill Fire Department (MFD) has 21 shift employees and 3 administrative personnel who work daily, Monday through Friday. 23 are cross trained in EMS and firefighting and 21 are paramedics. The majority of our run volume is EMS. We cover about 537 square miles with the ambulance service and a population over 20,000. We also

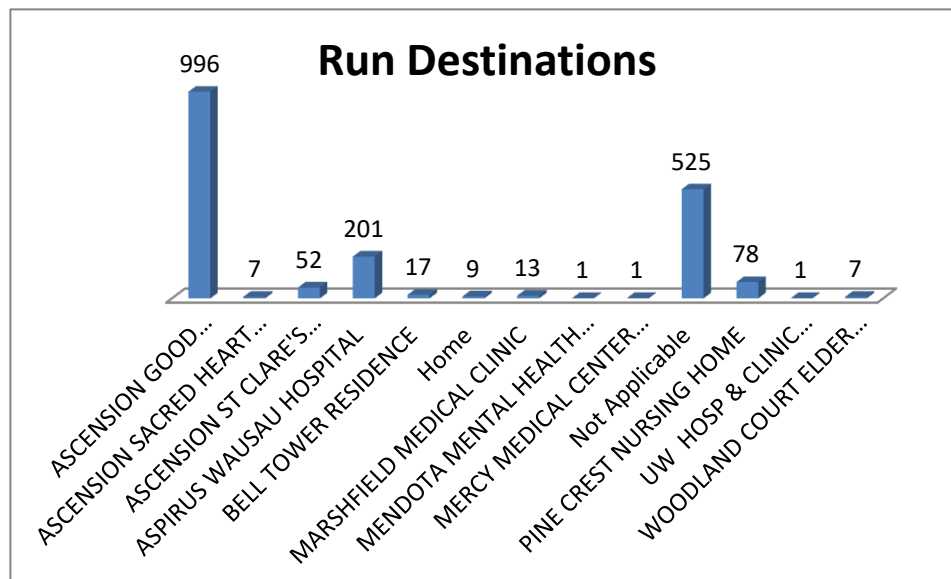
work closely with the 3 surrounding First Responder agencies in making the best service we can which includes great patient care from the start of the emergency to the transport to the appropriate hospital.



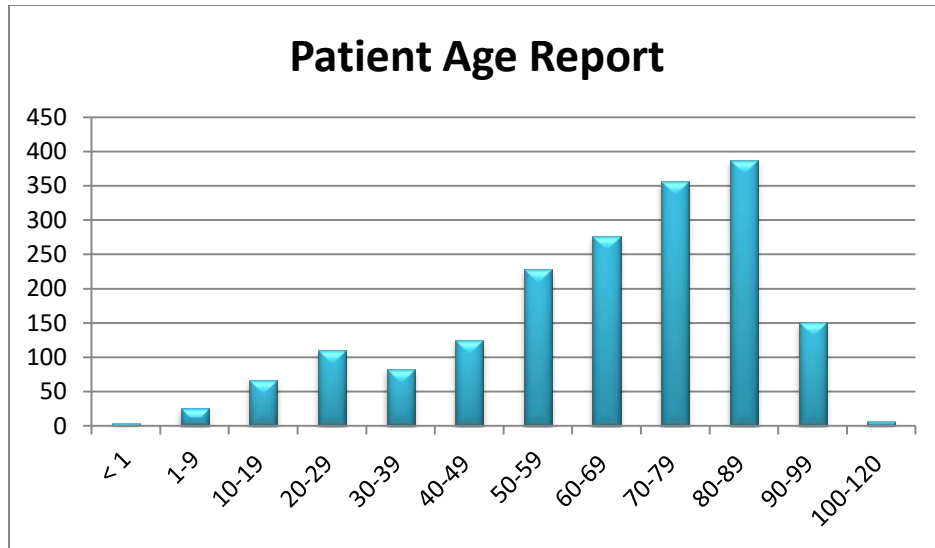
The Merrill Fire Dept. was established in 1888. In 1970 we began to run EMS calls. Prior to 1970, either the sheriff deputy or funeral home would transport a patient to the hospital. They would do what first aid they could and get them to more definitive care. In contrast, ambulances now are like mobile emergency rooms. They can give pain meds, cardiac drugs, defibrillate v-fib, start IV's and so much more. Merrill was one of the first EMT services in the state as well as one of the first groups to become D-fib and IV certified. The MFD started running paramedic ambulance in 2006. As you can see in the pie graph, most of the runs are made in the city, about 72%.



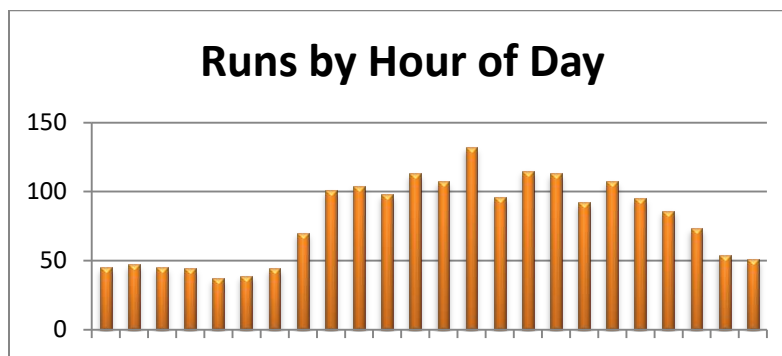
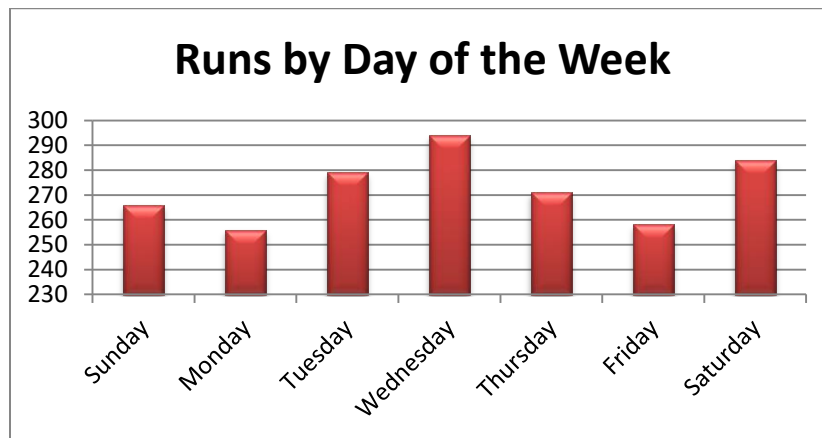
Almost 92% of our department's calls for service are EMS. We had 536 EMS runs in 1970, while in 2019 it was 1,908 EMS runs. The run volume has been on a constant increase through the decades; however, our staffing has decreased. In 1970, the department hired an additional 3 firefighter/EMTs taking them from 19 members to 23. In 1974, the department added another 3 firefighter/EMTs to bring their total to 25. The daily minimum staffing of the department was 7 personnel, but in 2008 it was reduced to 5. In the same year, our overall staffing was reduced to 23.



This graph shows where our ambulance patients are transported to. It's clear to see that Good Samaritan Hospital continues to be the most common site; however, it is worth noting that more patients are going to other regional hospitals like Aspirus Wausau Hospital. This is attributed to changes in health insurance, specialty centers, and transport protocol changes. The "Not Applicable" column reflects patients who were not transported by EMS.



The largest age groups are the 70 -89 year old patients which account for 39% of our run volume. As the Merrill community continues to age, we expect this trend to continue. In correlation to the age group, we will also likely see an increase to our run volume as well.



This year Wednesday was our busiest day of the week and the middle of the day we have the largest run volume. Unfortunately we cannot predict when an emergency occurs, but it is interesting data to review.

The Community Care Paramedicine Program (CCP) had been going for a few years now. It was put together in conjunction with Good Samaritan Hospital and our old Medical Director. It was started in part to reduce the return visits to the hospital while trying to keep the patient in their home setting as long as possible. We started with COPD, pneumonia, and CHF patients. It is a voluntary program to the patient that is funded fully by grant money at this time. The program actually started in October of 2017, but did not see its first patient until March 27th of 2018. Since then we have visited 41 patients with 40 follow up visits.

We still are involved in teaching CPR classes to the public. In 2019, we taught 228 people CPR and 124 people first aid. Some of the students taught, chose to take the online course and then came to us for the practical portion where we observed them doing their skills on our mannequins. We have 3 instructors, one on each shift.

Even though our EMS operations continue to function at a high level, we are recognizing the need for an improvement to our Quality Assurance (QA) and Quality Improvement (QI) program. QA/QI after calls is necessary and even required under the state's administrative health code. While we are currently in compliance with the law, it is very difficult to have consistent interaction and discussion with staff while working on shift. Someone working more typical administrative hours like Monday – Friday would improve this important oversight to staff. Additionally that person would have an easier time performing other administrative EMS duties like ordering ambulance supplies, updating our state EMS operational plan, providing hands-on training, writing EMS grants, and advocating for EMS changes through the state and other organizations that oversee our operations.

Community Events and Public Education

2019

The Merrill Fire Department takes great pride in being involved in community related activities. These activities give our members the opportunity to interact with citizens in a non-emergent atmosphere. We utilize this time to provide educational material in regards to fire and medical emergencies. Our efforts also include giving back to the community through the “Tree of Hope Program” and Merrill Firefighters Charities. Many of the events that the Merrill Fire Department is involved with are not only attended by on-duty personnel, but also include off-duty members along with their families that volunteer numerous hours of time.

The Merrill Fire Department strives to provide a “Between Alarms Value” to the community by hosting in-house trainings to citizens along with going out in the public to educate citizens of all ages on a variety of safety/prevention topics. We may never know how many accidents have been prevented by our efforts throughout the year, but we do know that by doing our part in being proactive instead of reactive the Merrill Fire Department and its members continue to make Merrill a great place to live and raise a family.

Firefighter Team Building Event

This event has been popular with High School and Middle School team related extracurricular activities.



Coaches of the teams have found this event to be a great way to get the participants of the team working together prior to the start of the season. Brian Suchocki head coach of the High School Wrestling team stated “This event is a great way to teach the importance of teamwork to accomplish a common goal”. This event is an opportunity for our members to reconnect with students prior to graduation since in most cases their last interaction with the department was during grade school fire prevention classes. During this event, many of the students ask questions about the requirements needed to become a firefighter/EMT. It is one of the ways the department tries to keep graduates in the Merrill area, or at least make them think about returning after they have completed their post-secondary education.

Mock Crash



This biannual event which started in 2002, is hosted at Jay Stadium and is intended to prevent injury and death to high school aged students and innocent bystanders caused by unsafe driving practices. Students are shown a prerecorded video in the auditorium prior to coming out to the football stadium where a crash scenario has been setup. A sequence of events plays out in real-time from the initial call to victim outcomes and legal consequences that the driver will face. It is a harsh reminder to all involved of how poor judgement can change lives forever. Approximately 650 students fill the stands to witness this event.

Hydrant Heroes



This event was coordinated by the Merrill Fire Department along with the City Street and Water Department. After a record snowfall late last winter /early spring, it was quickly identified that numerous fire hydrants throughout the city were not accessible which posed a threat to residents in the event of a fire. With the help of on and off-duty fire personnel, along with volunteers from the community, a grid system was established to effectively clear approximately 70 hydrants by hand in a timely manner. This event not only made it safer for the community, it also helped by freeing up manpower from the street and water department who were busy keeping the roads clear.

Community Night Out



For the 7th year, the Merrill Fire Department along with the Merrill Police Department assisted in organizing "Community Night Out". This event is held at the Festival Grounds and is a great way for different agencies and organizations to showcase what they have to offer to the community and answer questions. Last year's event had an estimated 400 people in attendance.

Smoke detector Installations

The Merrill Fire Department has partnered up with the American Red Cross to offer free smoke detectors with a 10 year life expectancy which are installed by our members. This program also includes a home inspection to inform citizens of other safety hazards along with suggestions on how to fix them.



Each household is offered up to 3 detectors. This program is at no cost to the city as all detectors are supplied by the American Red Cross. 44 homes in the Merrill area had new smoke detectors installed in 2019. This program started last fall and we expect a greater number of individuals to take advantage of the program in 2020. A number of the homes that we visited had no detectors at all or the detectors that were in place were well beyond their expected service life.

CPR, First Aid and Stop the Bleed Training

With a certified American Heart First Aid and CPR instructor on each shift we are able to teach individuals, employees of area businesses and students valuable information in performing life saving



measures according to the American Heart Association. These instructors also provide training on the proper use of Automated External Defibrillators (AED). These devices are located in several businesses, schools and churches around the city and can be the difference between life and death prior to EMS arrival when utilized by trained citizens. Every department member has been trained to teach “Stop the Bleed”. The “Stop the Bleed” program is designed to educate individuals on how to recognize life threatening bleeding and how to control it from simple direct pressure to applying a

tourniquet. These educational experiences are priceless for individuals to be prepared for an emergency at home, in their place of work or in the event of a large scale incident. In 2019 210 individuals were taught CPR, 1st Aid and AED compared to 164 in 2018. “Stop the Bleed” was new for 2019 and 90 individuals attended the training.

Fire Extinguisher Training



Individuals can be the first line of defense when it comes to a fire. This is why the Merrill Fire Department offers fire extinguisher training. Employers are often looking to educate their employees in regards to safety. Our fire extinguisher training is a great way to educate individuals on the safe and proper way to use a fire extinguisher. In 2019, 190 individuals were taught the proper use of fire extinguishers. Quick action taken on a small fire can prevent the loss of a home or severe

damage to a business which would lead to property loss for the business owner and displacement of their employees.

Fire Prevention Education in Schools

Nearly 1300 elementary students were taught fire safety education by our members throughout the

year before. The learning material has assignments which require students to work with their parents to complete. These assignments are crucial in educating not only the students, but the parents as well, about fire safety and what to do in the event of an emergency.

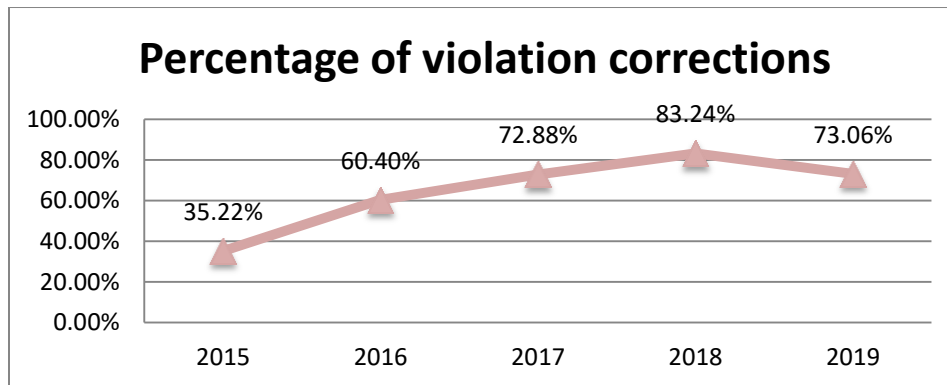
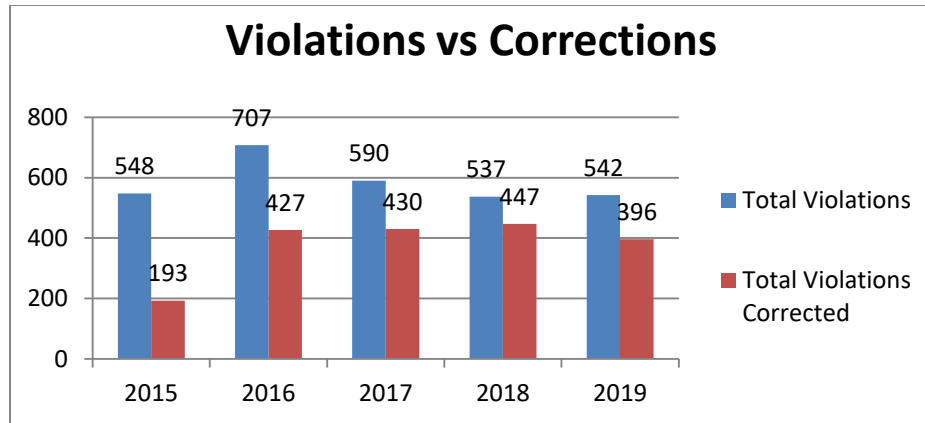
Inspections Division

This Merrill Fire Department's Fire Inspection program inspects all commercial properties as well as residential properties containing three or more families in the City of Merrill, Town of Merrill, Town of Rock Falls, and Town of Scott. These inspections are an opportunity to educate the owners and occupants about the fire and life safety codes that reduce the risk to the occupants and property loss through the practice of performing fire inspections. This is also an opportunity to build up a relationship with the business owners and property owners in the area we cover for fire protection. Below is a snapshot of the number of inspections performed by inspectors of the Merrill Fire Department.

*Denotes an inspection that had 9 violations and was determined that this property is no longer needed to be inspected as this didn't meet the definition of a public building and has been removed from the inspection list.

Following a DSPS audit of our inspections portion of the 2% dues audit, it was determined that we need to follow up on inspections to which violations had not been corrected since the original inspection was performed. Beginning the second half of our inspection period, we have begun to go back and visit the places that have unrepaired violations or have not returned their signed compliance statement regarding the correction of their violations. While the fire department does not issue citations for violations that go unrepaired, we work closely with the property owner to get these violations corrected before a reinspection fee is issued. As of this year it has been 4 years since the implementation of the reinspection fee for those not choosing to correct their violations. As of this year, there are no reinspection fees assessed to any owner or occupant of a building.



In addition to the required fire inspections, the Inspection Division performs additional inspections including but not limited to: fire alarm acceptance tests, sprinkler system acceptance tests, fire pump acceptance testing, occupancy load calculations for assembly occupancies, and other various inspection related duties.

The biggest complaint we hear from local business owners is the inconsistency of our inspection program. Since we currently conduct inspections with multiple crews, different violations are observed at different times. With the increase of re-inspections and the challenge of staying current with fire code changes, the department will need to address how we can manage those issues. These issues indicate that one position that can manage inspections more efficiently and effectively.

We will continue our hard work and dedication to the residents, business owners, and visitors of the City of Merrill and the surrounding towns in providing a great safe environment for all to enjoy. Our goal is to reduce the amount of violations occurred during these inspections by working with and educating them in how to prevent fires and injuries in their place of employment or ownership.

TRAINING DIVISIONAL REPORT 2019

2019 was another year of changes to the Training Division for the Merrill Fire Department. Outlined below are the changes and events highlighting the training received this year.

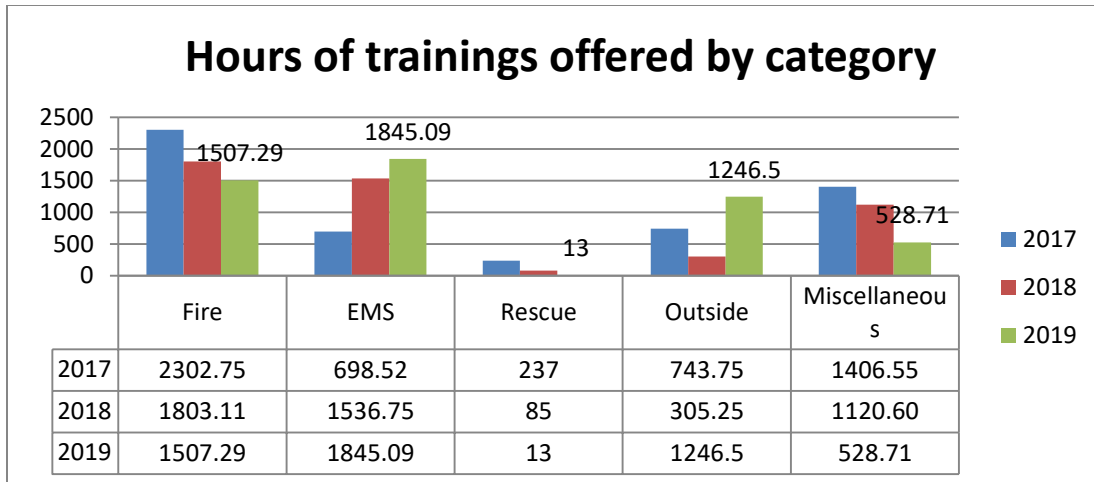
2019 brought the introduction of the Temporary Supervisor's task book. Temporary Supervisors are in charge of each shift in the absence of a Battalion Chief for their respective shift. The purpose of a task book is to ensure that the Temporary Supervisor has all the knowledge and skills that is needed to run the day to day operations of the Merrill Fire Department prior to being placed in the position for their initial shift. Temporary Supervisors are also required to be job shadowed/ mentored by their respective Battalion Chief three times throughout the year. This gives the Battalion Chief a chance to evaluate the Temporary Supervisor and provide feedback on their performance for potential Battalion Chiefs openings in the future.



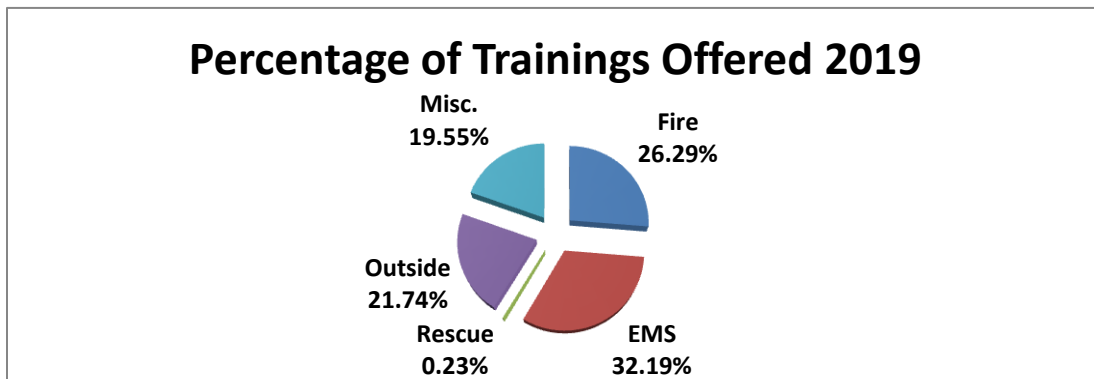
In the spring of 2019, 17 members of the Merrill Fire Department attended the 36 hour State of Wisconsin Certified Driver/Operator- Aerial class taught by North Central Technical College. There were 2 separate classes taught at the Merrill Fire Department to accommodate staffing during class time. We had 3 department members' that were already Driver/Operator- Aerial certified prior to this class being held. Upon completion of the class all 17 members are now State of Wisconsin Driver/Operator- Aerial Certified.



In addition to training Merrill Fire Department personnel, we also held joint training's with our surrounding fire departments. In August and September, we gave a presentation on our aerial device for Tomahawk Fire Department and Town of Russell Fire Departments. Also in September, there was a combined drill with the Town of Russell Fire Department, Corning Fire Department, and Pine River Fire Departments regarding pumper operations with rural water supplies and making fire hydrant connections when in the city.



In 2019, there was a change to our training philosophy as we started to implement the reintroduction of weekly shift skill drills. The weekly shift skill drills involved both fire and EMS related tasks to ensure that staff becomes familiar with and proficient in performing these tasks while in emergent situations when needed. Shift Emergency Services Instructors were in charge of delivering and evaluating these weekly shift skill drills.



Besides the training we do in-house, we also offer for individuals to attend training outside of the department. This allows our personnel to become educated in the latest strategies and tactics to further improve the service we provide to the public. While a majority of the outside training classes pertained to fire and EMS operations, several members took advantage of learning more about the mental and psychological aspect of being involved in emergency services. This has been a hot topic in emergency services the past few years due to the high physical and emotional stress placed on responders.

In 2020, we will continue to improve our training programs so that our members continue to be highly trained and skilled in our all hazards response to request for service.

MAINTENANCE DIVISIONAL REPORT

2019

As the Battalion Chief in charge of the Vehicle Maintenance Division, it is my goal to ensure that all apparatus driven, engines pumped and associated equipment utilized is in working order and safe to use under emergency situations. As in the past we have relied on the Merrill City Garage to perform our vehicle maintenance. We are fortunate to have ASE qualified mechanics to perform maintenance on all of our vehicles. They handle Department of Transportation (DOT) annual vehicle inspections, preventive maintenance, routine maintenance and provide afterhours assistance.

A very important facet of tracking our vehicles maintenance needs is when a vehicle is fueled at the city fuel pumps the engine hours are entered and the Fleet Maintenance computer system (Pubworks) software identifies the need for work based on those hours. Another vital part to the (Pubworks) is when the need for maintenance is found in-house we submit a maintenance request via E-mail on an established form and follow it up with a call to city garage if the work needs to be expedited.

Dustin Bonack has been the Street Commissioner for 4 years now and he and his support staff have been instrumental in keeping us in a high state of readiness. We have cultivated this relationship over the years. We would also like to thank Melissa (Administrative Assistant) and the mechanics, Bob and Mike for their role in our maintenance program.

These costs incurred are only from the city garage for the entire year of 2019. There are additional maintenance costs for our fleet, but they are not included below on this report. We hope to include those in the future, so we can give elected officials an overview of the money that is spent maintaining our emergency vehicles. Annual costs for vehicle maintenance are as follows:

- ✓ All frontline ambulances (3), reserve ambulance (1).
 - ✓ Labor cost- \$1,342.46
 - ✓ Parts cost- \$1,049.47
- ✓ All other vehicles: Aerial (1), Engines (2), Tender (1), Squad (1), Brush truck (1), Utility truck (1) and Command cars (2).
 - ✓ Labor cost- \$3,008.43
 - ✓ Parts cost- \$5,410.18

*These costs would have been significantly higher if repairs needed to be made by a private vendor.

While we are fortunate to now have a reserve ambulance which allows us to maintain our normal EMS operations, it is unacceptable to have that much out of service time on a new vehicle.
