- New STF loan for City Hall roof replacements included in the 2020 City Capital budget. Interest rate for ten-year loan would also be at 3.25%.

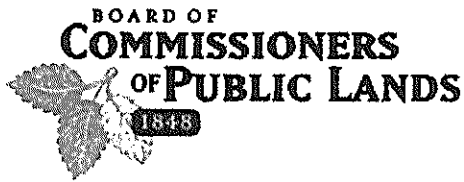
Under Wisconsin Statutes, only ten-year financing is allowed for City Hall improvements.

Fund 43 - City of Merrill Tax Increment District No. 3 received \$1,466,115.00 in net borrowed proceeds (i.e. after fees deducted) on Wednesday, 10/30th.

This allowed TID No. 3 to reimburse the City General Fund \$633,942 for 2019 capital improvement expenditures. The City also paid Merrill Gravel & Construction Co. \$562,707 for the E. Main St. (Hwy 64) improvements on 10/31st.

Borrowing – 2019:

The City of Merrill received the Series 2019A (GO Bonds) borrowed proceeds wire (\$1,880,000.00) on Tuesday, 11/5th. These funds reimburse \$1,088,532.40 in cash flow advances from the General & Utility Funds for 2019 infrastructure investments (as detailed on attached spreadsheets).

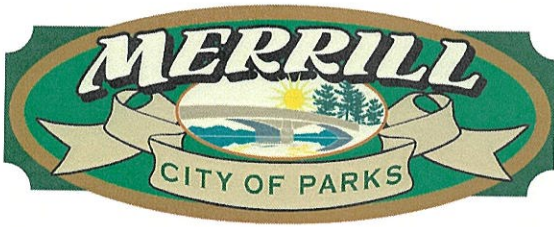

Administrator's Report 12/21/19 – 1/21/20

New Development and Blight elimination

On Monday January 6, Bill Bialecki and I met with the individuals interested in building a supper club style restaurant in front of the old Walmart. Their plans had been put on hold due to their purchase of another restaurant but they would like to proceed with the Merrill project.

On January 8, members of the Merrill Area Development Corporation met to discuss the status of the former Hurd property. We will continue to pursue the eviction action. It was decided that we need to do an inspection of the interior of the buildings. This inspection took place on January 14.

Unfortunately we received a phone call from Impact Seven stating that they would not be proceeding with their proposed project on the former Fox Point site. To date, they had met with us several times, given us an earnest check, performed a new Phase I Environmental Study, surveyed the site, and drew up two alternate site plans which they shared with us. After a recent Board of Director Meeting their Board decided to pursue a project in what they termed "a better market".

Bill Bialecki and I met to discuss new restaurant development. The new restaurant east of Park City Credit Union is moving forward, the owner has contracted with an architect and is moving forward with the building design.

On January 10, we attended a meeting at Church Mutual with President and CEO Rich Poirier, two representatives from Incredible Bank, the President of Park City Credit Union, and developer to discuss a potential project on the former Anson Gilkey property. There is a lot more work to be done on this potential project.

On January 13, I prepared the interview questions to be used in filling the vacancy created by Kathy Seubert's retirement.

On January 15, I met with a representative of another manufacturing firm that is interested in expanding their facility in Merrill. More information will be forthcoming.

On January 16, we met with a representative of SEMCO to discuss potential use of the SEMCO site next to the Park St. trailhead for development. We had already met to discuss this property with SEMCO prior to their closing.

On January 21, we received a request for information on the former Fox Point site from a developer. I sent them an aerial map, a CSM, a utility map, a topological map, the Phase I Environmental Study, and the history of the site. They also asked about the availability of TIF assistance. While the Impact Seven project did not work out there are still other developers out there looking for opportunities.

Festival Grounds

The first gun show of 2020 was held at the Expo Hall in January with others to follow in 2020.

We have another wrestling event scheduled for March in the Expo Hall.

Personnel

On January 3, we had a retirement lunch in City Hall for Kathy Seubert who retired after forty years and one month of service to the City.

I spent part of several days completing the 12 annual employee performance evaluations I am responsible for and am now more than half way through meeting with Department Heads to go over their evaluations.

We still have not settled the Fire Department labor contract. We now have new officers in the union due to recent election and hopefully we can move forward with a mutually beneficial contract.

We received 35 applications for the vacancy created by Kathy Seubert's retirement, with one received after the published deadline. I first reviewed all the applications and they were then reviewed by Kathy Unertl, Jill Bostrom, Brenda Greffe, and Cheryl Plautz. We chose the six individuals we felt would be the best fit for the position. If none of these interviews had worked out we would have gone to the next group of six. We held the six interviews on January 15 and 16 with Kathy, Jill, Brenda, and me participating. In the interviews there were two individuals who stood out from the others, with one of these two standing out from the other one. There was unanimous agreement on who was the best candidate for the position. With this unanimous agreement I authorized Kathy Unertl to offer the position to Stephanie Pagel. Stephanie has worked at the Water/Sewer Utility since February 27, 2017. She is familiar with our Incode and Executime programs, our billing process, accounts payable, and customer service. She has applicable skills from previous employment, including 14 years of office experience with Wausau Papers. There is no problem with our nepotism policy as her husband Darin works in another department and has no supervisory authority over this position. It is always good to promote from within when we can, it demonstrates the ability for advancement in the City. We are in the process of now advertising to fill the vacancy in the Water/Sewer Utility. The Water/Sewer position needs to remain a full-time position, in the past it was part-time for a while and we had difficulty filling the position and difficulty retaining employees in the position. Rod and Gabe concur that this needs to remain a full-time position. Stephanie is the second full-time employee to be promoted into the Clerk/Treasurer's Office from the Water/Sewer Utility position since I have been City Administrator. Letters have been prepared and sent to all those who applied letting them know that the position has been filled.

The week of 1/20/2020, the Lincoln County Highway Department terminated an employee for a positive random drug test for THC that was supposedly the result of using CBD oil.

Miscellaneous

On December 23, the Chamber had the ribbon cutting for Inlusa's new office in Merrill. Inlusa, Inc. was formed to leverage years of experience in delivering a person-centered and community-focused approach to the Family Care program. Inlusa receives 100% of its funding from the State of Wisconsin.

On the afternoon of Friday January 3 we met with representatives of the Office of Workforce Development to discuss SEMCO's closing and what could be done to assist the affected employees. We offered the Festival Grounds' Expo Hall for an employee meeting. On Tuesday January 7 we again met with representatives of Workforce Development and the Labor, Education, and Training Center to plan the meeting at the Expo Center, as well as work out the details for a job fair with local employers. On January 8, an evening meeting was held with more than 90 SEMCO employees in attendance and more than 40 area employers attending the job fair. I have been getting phone calls from potential employers from as far away as Illinois and all over Wisconsin. The latest inquiry was on January 21.

On January 7, I did an interview with WSAW concerning the SEMCO closure.

Steve Hass, Josh Klug, Nick Wszalek, and I met on January 8 to discuss continuing issues with the Fire Department HVAC system. It was decided to hire an engineering firm to assess the issue of too much humidity in the building and how it can be rectified.

Mike Ravn and I met to discuss the status of the Strategic Plan. I also again met with Gene Bebel at his request on to discuss his concerns about the Strategic Plan.

On January 15, I attended the United Way Executive Board Meeting at the Menard Center. One of the topics of discussion was the extensive use that is being made of the homeless and warming shelter.

On January 15, I attended the Merrill Chamber of Commerce Board of Directors Meeting. New Chamber Board Members were again introduced.

On January 20, Rod Akey and I met with John Krohn, president of the River Bend Trail Foundation to discuss future plans for the trail. The idea being discussed by the River Bend Foundation is a trail north to Tomahawk and south to Wausau. This would be a bike trail like the Heart of Vilas County Paved Bike Trail System that offers riders more than 52 miles of paved trails connecting St. Germain, Sayner, Boulder Junction, Manitowish Waters, and Mercer.
